LOCATION

North Ayrshire is located in the southwest of Scotland, and borders the areas of Inverclyde to the north, Renfrewshire to the northeast and East Ayrshire and South Ayrshire to the east and south respectively.

The site is in a rural setting and most amenities are drawn from nearby Kilwinning. The majority of holiday attractions can be found 7 miles to the west in the coastal towns of Saltcoats and Ardrossan.

The site is immediately adjacent to Viewfield Manor Holiday Village on the southern side of the A736 carriageway.


DESCRIPTION

The subjects comprise a sizeable leisure development site extending to approximately 22.7 acres. The site in general is of relatively flat topography and regularly shaped.

The site currently benefits from planning permission for 196 static caravan plots. The occupancy of any caravans is to be limited to 11 months in any 1 year and not to be used as permanent residential dwellings.
