LOCATION

Bridge of Allan is a town in the Stirling council area in Scotland, just north of the city of Stirling. It lies on the Allan Water, a northern tributary of the River Forth, built largely on the well-wooded slopes of the Westerton and Airthrey estates, sheltered by the Ochil Hills from the north and east winds. Most of the town is to the east of the river; the bridge is part of the A9, Scotland's longest road, while the railway line and the M9 pass to the west of the river. Bridge of Allan railway station is on the Edinburgh to Dunblane Line.

The subjects are located on the southern side of New Street near to its junction with Henderson Street. Henderson Street forms the main arterial road through the town leading to Stirling and as such benefits from a high level of passing trade.

DESCRIPTION

The subjects comprise a ground and first floor office contained within a three storey building of stone construction surmounted by a pitched and slated roof.

Internally the ground floor offers entrance hall, w.c, two office suites and kitchen area. The first floor provides two further office suites. The unit benefits from recently being fully refurbished to an extremely high standard throughout:


