LOCATION

Kirkcaldy is a town and former royal burgh in Fife, on the east coast of Scotland. It is about 12 miles north of Edinburgh and 28 miles southwest of Dundee. The town had a recorded population of 49,460 in 2011, making it Fife's second-largest settlement and the 11th most populous settlement in Scotland.

The town is a major service centre for the central Fife area. It has a swimming pool, theatre, museum and art gallery, three public parks and an ice rink. The A92, which connects Dunfermline to the west with Glenrothes and Dundee to the north, passes immediately north of Kirkcaldy.

The subjects are located on the eastern side of St Clair Street between its junctions with Viewforth Street and Longborough Road.

DESCRIPTION

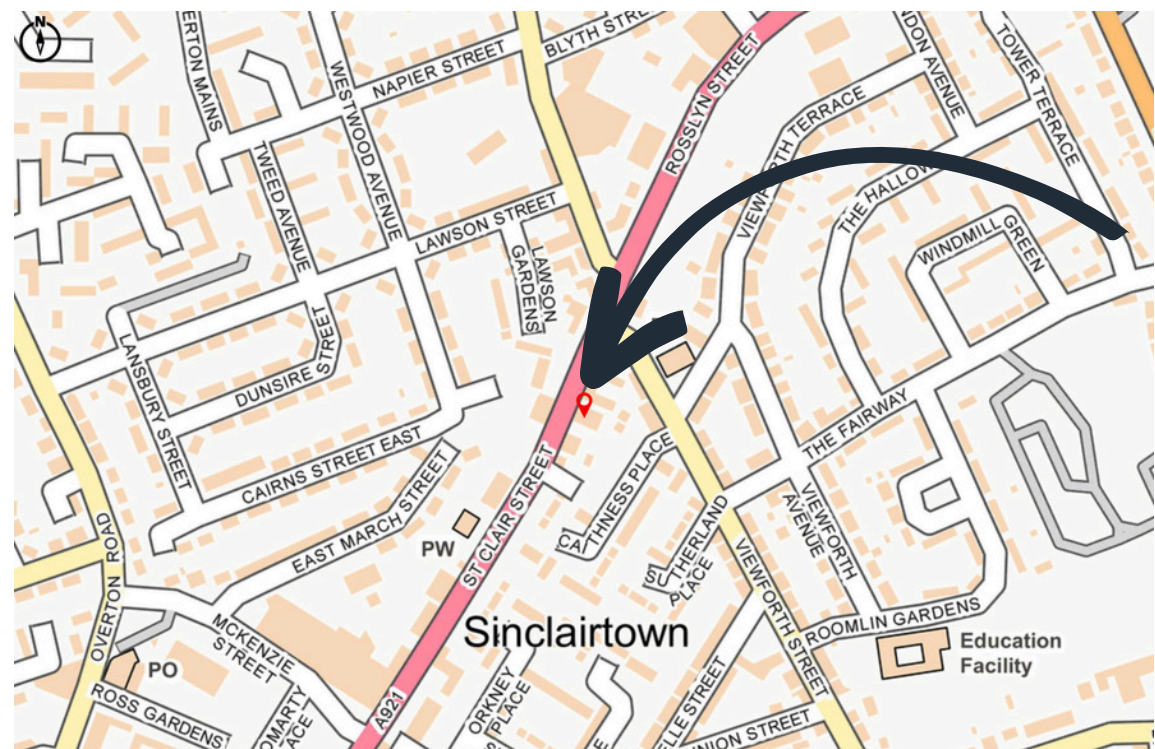
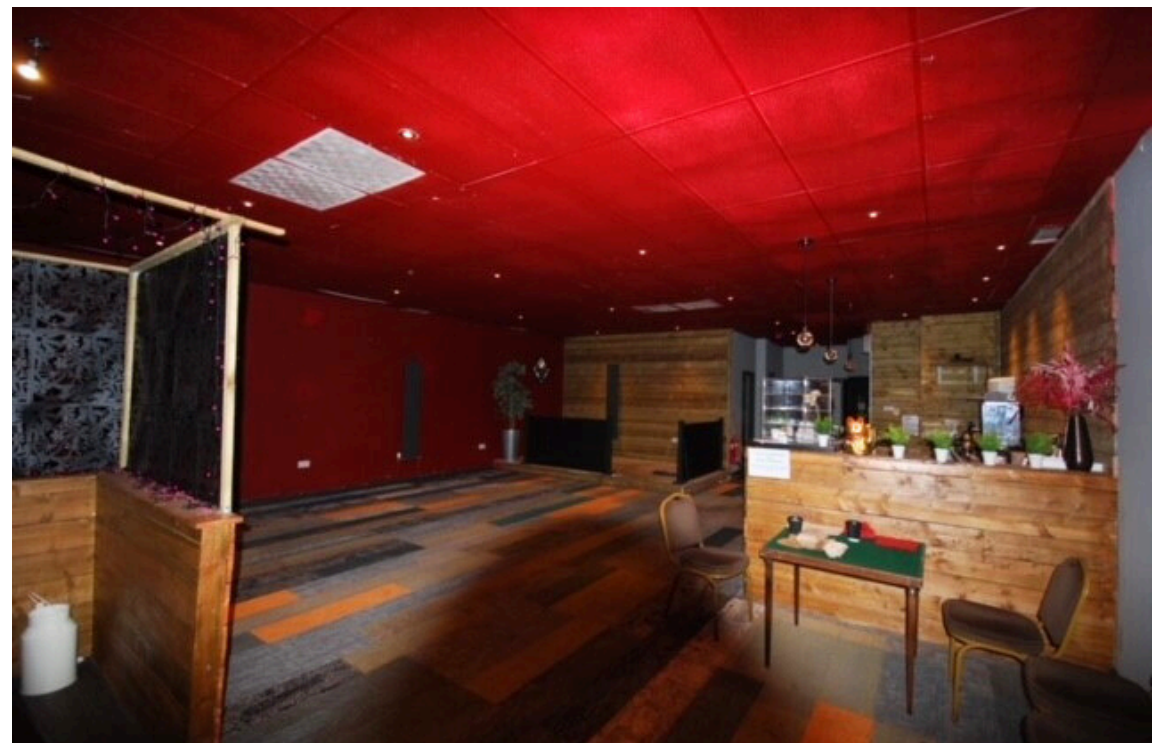
The subjects comprise a 2-storey building of stone construction. The ground floor was a former restaurant with the first floor a 2 bedroom residential flat. Access to the property is from the front and rear. The upper floor could be sold off separately if required.

The ground floor is divided into a good sized seating area with bar servery. In addition there is a large kitchen to the rear with the remainder of the accommodation providing storage and toilets.

The first floor provides a large residential flat with accommodation comprising of a hall, living room, 2 bedrooms, dining/kitchen and bathroom.

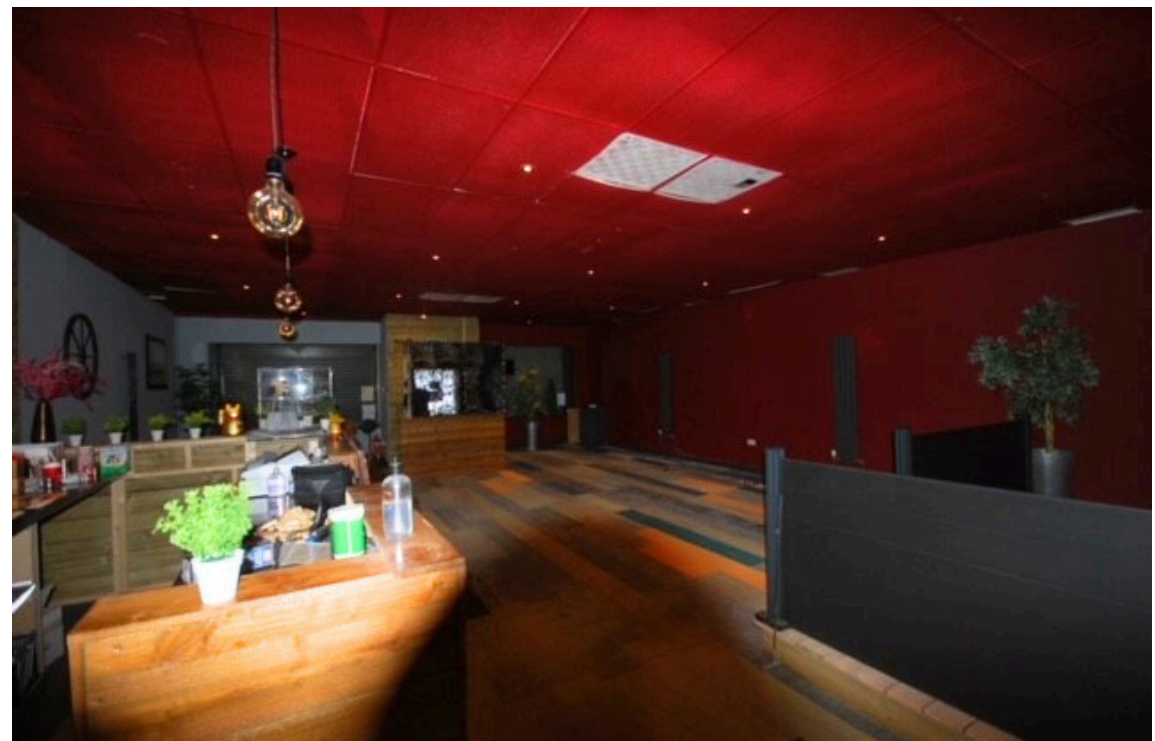
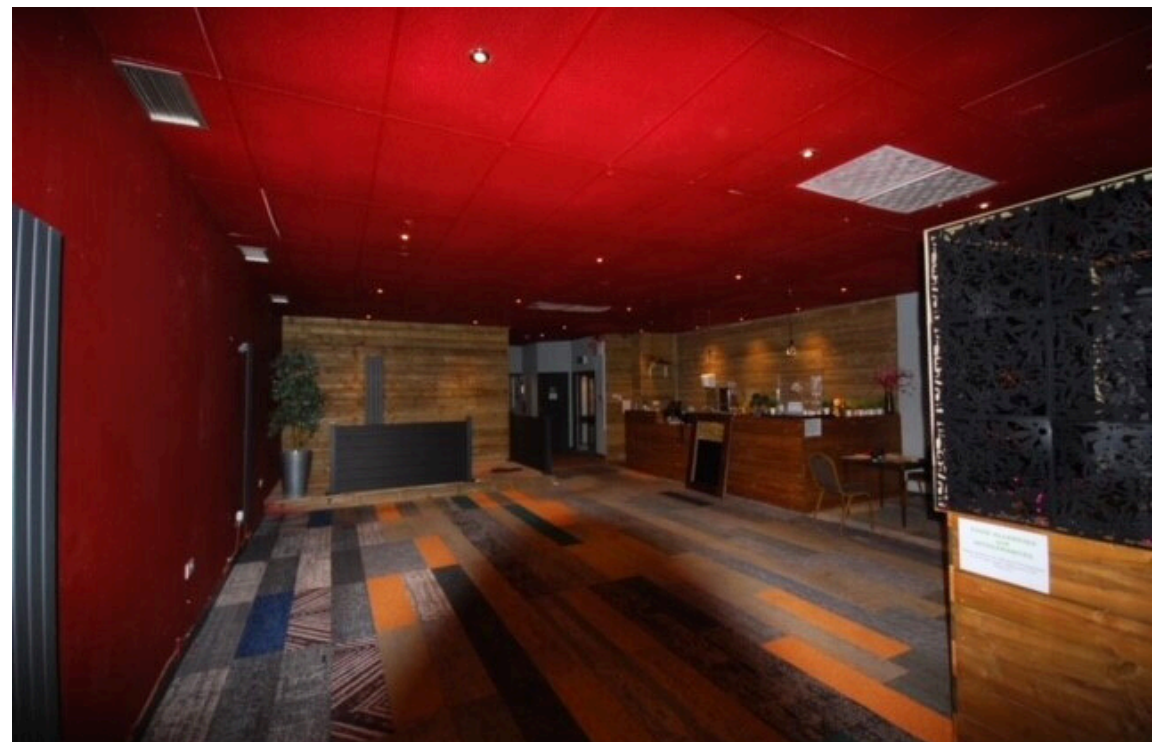
