LOCATION

Perth is a city in central Scotland, located on the banks of the River Tay. It is the administrative centre of Perth and Kinross council area and the historic county of Perthshire. According to the preliminary 2011 census results Perth, including its immediate suburbs, has a population in the region of 50,000.

Perth's city centre is situated to the west of the banks of the River Tay. The pedestrianised portion of the High Street, which runs from the junction of St John Street to Scott Street, is the main focus of the shopping area. The centre has a variety of major and independent retailers.

From a local context the property is situated on the eastern side of Kinnoull Street at its junction with Carpenter Street.

DESCRIPTION

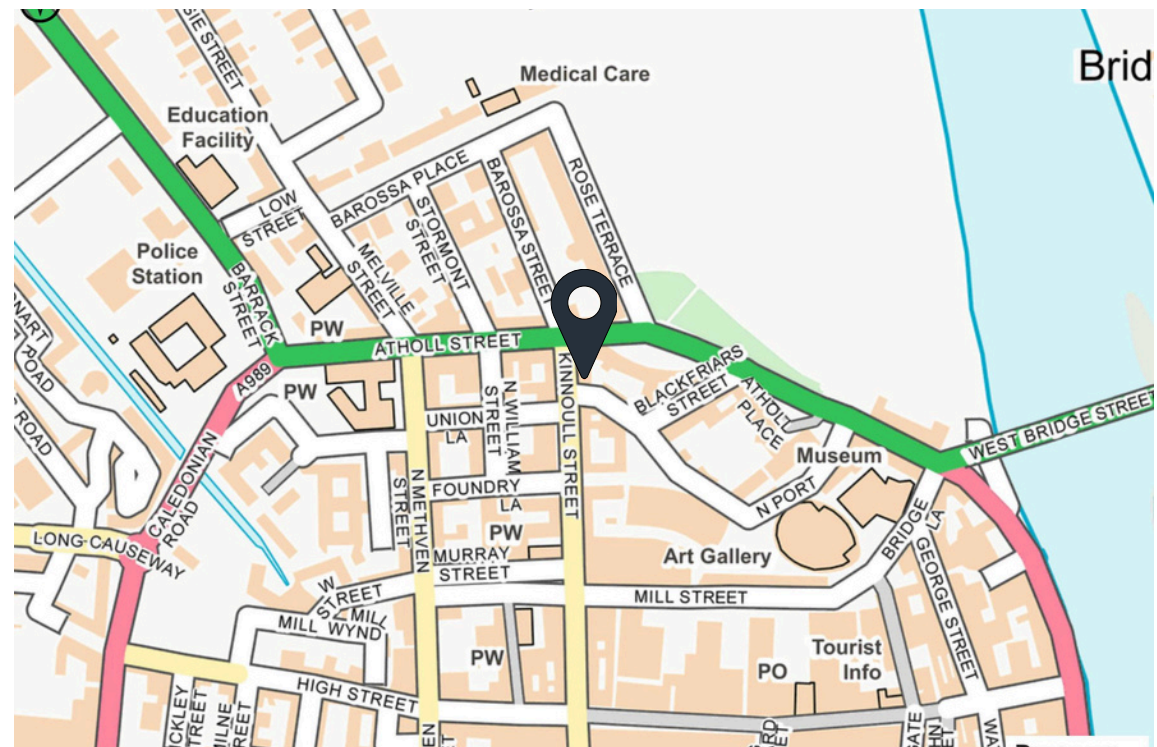
The subjects comprise a ground and basement floor retail unit contained within a three storey and attic building of stone construction.

Internally the property has been refurbished to an exceptionally high standard. The floor is overlaid in a ceramic tiled finish whilst the walls and ceilings are plastered and painted. Air conditioning and gas central heating have recently been installed.

The basement provides kitchen, w.c and large storage area/office.
