DESCRIPTION

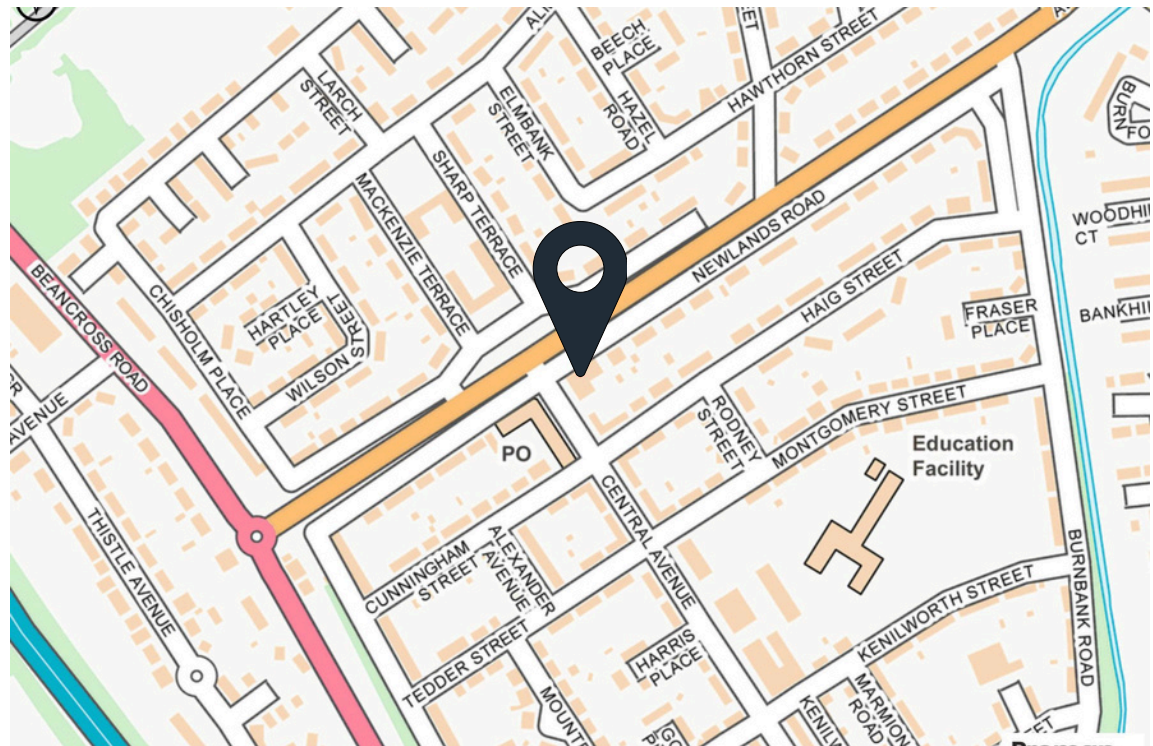
The property comprises a first floor former function suite contained within a 2-storey building of brick construction with a roughcast finish surmounted by a pitched and slated roof.
