LOCATION

DESCRIPTION

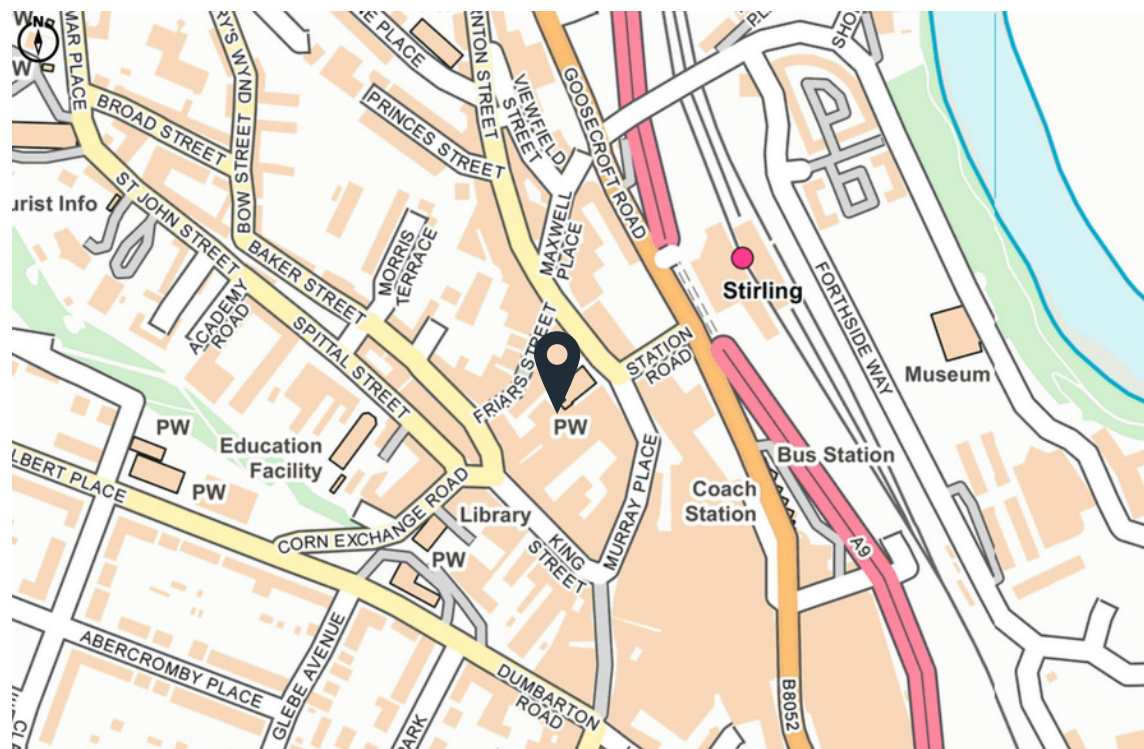
The subjects comprise a ground floor retail unit located within a boutique Victorian retail arcade.
